Prayer:-

WHEREFORE, in view of the foregoing, the petitioner most respectfully prays that this Hon'ble Court may be pleased to:

- A. Direct the respondents to promptly and expeditiously consider the petitioner for appointment against the available vacancy for the post of Social Welfare Officer BS:17, as per the petitioner's rightful position in the waiting list.
- B. Mandate the authorities to extend the validity period of the merit list, if necessary, in accordance with Rule 63 of the PPSC Regulations 2022, to ensure the petitioner's rightful opportunity for appointment is preserved.
- C. Safeguard the petitioner's legitimate expectations and protect the petitioner from suffering irreparable loss due to the expiration of the merit list's validity period, which remains valid only until 29/09/2023, with only a month remaining.

Pass any such further or other orders as this Hon'ble Court may deem fit and proper under the circumstances of the case



On the recommendations of the Punjab Public Service Commission vide letter No. PSC-RG-I/2022/210-RG dated 16.10.2023, you are hereby offered appointment as Social Welfare Officer/Medical Social Officer/Deputy District Officer (BS-17) in Social Welfare and Bait-ul-Maal Department, Punjab, on contract basis for a period of five years, on the following terms & conditions:-

1. **PAY PACKAGE:**

- Pay and allowances as per pay scale of the post.
- 30% of the minimum of pay scale as social security benefit in lieu of pension.
- Any ad-hoc/special relief etc, as and when given to the regular Government servants shall also be admissible to you.
- Annual increment as per pay scale of the post.

2. **MEDICAL FITNESS CERTIFICATE:**

You will have to appear before the Competent Medical Authority/Board in Services Hospital, Lahore for medical examination and on having been declared fit you will be eligible to join service.

3. **TENURE:**

The period of contract will be for five years with effect from the date of assumption of the charge of the post.
